SPECIAL ELECTION FOR HOUSE SEAT 30

The Mississippi Secretary of State has released the state ballot for a special election and in a few weeks, some citizens of Bolivar County will make their way to the polls to cast their vote in a very special election this year, the May 8th Special Election for House Seat 30 which is the seat to replace a long-time representative who recently retired, Robert Huddleston of Sumner, MS. The *ONLY* precincts involved in this election are:

Boyle

Cleveland Courthouse

South Cleveland (Partial)

Shaw (Partial)

West Central Cleveland

{Voters In Partial Precincts May Contact The Circuit Clerk's Office To Know If They Are Eligible To Vote}

The Bolivar County Election Commission has worked diligently in the last few weeks to ensure that the voter rolls are accurate and that the county's streets are redistricted correctly for this race.

The Commission strives to make all elections run as smoothly as possible by keeping voters informed of dates, precinct changes, poll worker training, etc. This is a colossal responsibility and they do not take it lightly. We ask all of our citizens to report any street or voter record discrepancies to their election commissioner:

Election Commissioner District 1 (West Bolivar) – David Washington

Election Commissioner District 2 (Central Bolivar) – Billy Davis

Election Commissioner District 3 (North Bolivar) -- Shelia Perry

Election Commissioner District 4 (East Bolivar) - Yvonne Hannah

Election Commissioner District 5 (South Bolivar) Ora Jackson

There are a few reminders we wish to stress to voters. Please be advised that the last day to register to vote in *THIS* particular election is April 7th.

If anyone has *recently* registered to vote, whether with the Circuit Clerk's Office, an organization or any other agency, and have not received a Voter Registration Card, please contact our office. This card is your confirmation that you have been registered on the Bolivar County Voter Roll.
